New York Energy Solution is Fully Energized!

I'm pleased to report that the New York Energy Solution electric transmission modernization project is fully energized and serving homes and businesses – six months ahead of schedule!

New York Transco celebrated this milestone moment on Wednesday, August 16, with a ribbon cutting ceremony adjacent to the northernmost portion of the rebuilt 55-mile transmission corridor in the town of Schodack, Rensselaer County. We were pleased to be joined by officials from New York State, as well as labor, business, and environmental organizations, all excited by what our project means to the state's economy and nation-leading clean energy goals.

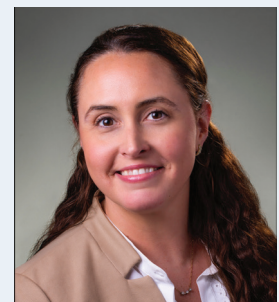
Not only will our project help clear up congestion on the state's electric grid and allow for greater amounts of clean energy to flow from where it's generated to the people who need it, the new transmission infrastructure is better designed to withstand severe storms and provide greater reliability to customers.

New York Transco President Vic Mullin told those gathered that "collaboration, cooperation and communication" with the 11 host communities and more than 500 adjoining property owners throughout the design, permitting and construction processes were key to helping the project go so smoothly.

In the weeks ahead, we will be continuing our work to restore the transmission corridor and those lands around the project stations. We will keep you updated on our progress. 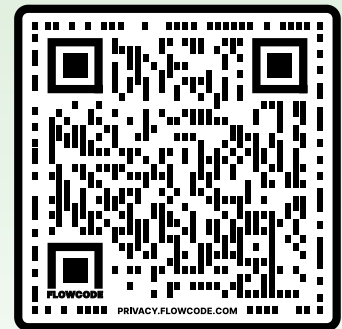
